1. \$2,000 Workplace Specific Scholarship Eligibility Criteria

There are three Workplace Specific scholarships of \$2,000 each.

1. Open only to members presently employed by one of the following:

2. The UFCW Local 832 member is the person who will be attending school.
3. Member must be in good standing with UFCW Local 832.
4. Only one UFCW Local 832 scholarship will be awarded per life-time per member.

2. \$1,000 General Scholarship Eligibility Criteria

There are 18 General scholarships of \$1,000 each.

1. Open to members, presently employed by a company that has agreed to make contributions to the Education and Training Trust Fund, and their dependent children—see list of companies on page five.

2. Only one UFCW Local 832 scholarship will be awarded per life-time per member; however a member with more than one dependent could receive an award for each dependent child.
3. Member must be in good standing with UFCW Local 832.
4. This scholarship must be used in the academic year it is granted.

 4. Member may be eligible for other UFCW Local 832 scholarships.
 5. Member does not have to be attending post-secondary education.

4. \$500 Adult Grade 12 Grad Scholarship Eligibility Criteria

There are two scholarships of \$500 each for the Westman region and two scholarships of \$500 each for the Winnipeg area (for a total of four).

1. Open only to members presently employed by a company that has agreed to make contributions to the Education and Training Trust Fund.
 2. Member must be graduating from Adult High School offered through Assiniboine Community College (ACC) in the Westman region or through Manitoba Institute of Trades and Technology (MITT) in Winnipeg. These awards will be presented at the ACC grad in Brandon and the MITT grad in Winnipeg.
 3. Member must be in good standing with UFCW Local 832.
 4. Member may be eligible for other UFCW Local 832 scholarships.
 5. Member does **not** have to be attending post-secondary education.
