

#### MESSAGE FROM THE PRESIDENT

FCW held its 7th regular convention in Chicago last month and Local 832 delegates spoke on numerous resolutions that will help shape our union for the next five years. The theme for the convention was Blue. Gold. Bold. Powerful Together. Under the leadership of Joe Hansen, UFCW International President (who is featured on our cover), our union has grown stronger while continuing to fight for working people globally. Today's world is a small one and if we are going to effectively represent our members, we need to be able to apply pressure to the many global employers we negotiate with.

Even though the majority of UFCW's 1.3 million members come from the United States, Tom Mulcair, Leader of the Official Opposition here in Canada, spoke to the delegates at the convention. "UFCW is a leading force in Canada," he said. "Fighting for greater social justice, challenging the ultra-conservative agenda at every turn, and fully mobilizing in political action to create a better future for working families across the country."

Canadian Labour Congress President Ken Georgetti brought greetings of solidarity and challenged the delegates to "dramatically improve the number of workers who can call UFCW "my union." "It will be difficult, it will be a challenge like no other in our lifetime, but if our words reflect the values most people believe in, like fairness, we will win."

Anyone involved in union management relations in North America is aware that there is a war going on and workers are in danger of losing all that they have gained through generations of bargaining. We must continue to educate our members on the importance of their role in their workplace, and on the importance of where they shop and how they vote.

The radical right in the US and the Harper agenda in Canada are in a battle with unions and the labour movement, but if we stand strong and united we can win this fight. We can protect the rights of working people as we have done so many times in the past and we can be powerful together!



he windy city of Chicago was home to nearly 2,000 UFCW delegates, alternates and guests from August 12 to the 15. Delegates discussed resolutions that will shape our union's future and heard from dynamic politicians, activists and labour leaders.

It was announced early on the first day of the convention that after an eight-year absence, UFCW would be rejoining the AFL-CIO. Richard Trumka, president of the AFL-CIO, and Ken Georgetti, from the Canadian Labour Congress, brought messages of solidarity and both speakers challenged delegates to work hard and take back their countries for the working class.

NDP Leader, Tom Mulcair, spoke about the importance of UFCW in Canada.



The last speaker on Wednesday, August 14 was a highlight to many of the delegates as Congressman John Lewis brought the convention to their feet numerous times. He's been called "one of the most courageous persons the Civil Rights Movement ever produced," Congressman Lewis broke script and spoke from his heart,

"If it had not been for you and for organized labour, I would not be in the House of Representatives today. I'm ready to fight with you. I'm not too old to sit in, to sit up, to speak out, or speak up."

International President Joe Hansen, Secretary-Treasurer Marc Perrone and Executive Vice-Presidents Bill McDonough, Pat O'Neill and Wayne Hanley along with the 46 vice presidents at large, and four vicepresidents of UFCW Canada, were all elected at the convention. A resolution was passed to add one more vice-president from Canada.

In his keynote address, President Hansen reminded delegates about the commitment to the future of the union by organizing, and he confirmed that since the last convention in Montreal that is exactly what has occurred.

UFCW Local 832 delegates were busy at the microphone over the four days discussing resolutions for migrant workers, bargaining and protection for workers at their workplace.

The final speaker of the convention was activist, actor and union member Ashley Judd. While many know her for her many movie roles, she highlighted how she realized early in her career that negotiating specific clauses in her contracts had a benefit to the other unionized workers on her movie shoots. Sister Judd has been an outspoken advocate for political and humanitarian missions.

his summer saw another mega-merger in the retail food landscape when Loblaw made a \$12.4-billion purchase of Shoppers Drug Mart. The deal many thought was in reaction to the Sobey's \$5.8-billion purchase of Safeway Canada.

Annual revenue of the combined company would have been more than \$42 billion in 2012, according to the Loblaw statement announcing the purchase. Loblaw, based in Brampton, and Toronto-based Shoppers Drug Mart together made earnings before interest, taxes, depreciation and amortization of about \$3 billion last year.

The union believes this is enough to ensure the members in Manitoba can receive a fair wage increase.

## Injury Reporting

verybody likes to work safe, however, accidents can happen and you need to know what to do if you do get injured at work. Local 832 continues to receive questions about reporting injuries in workplaces or complaints about poor reporting systems when WCB denies a claim because of errors or omissions on management's part.

WCB Notice of Injury forms (better known as Green Cards) should always be used to report injuries in the workplace, even if no time off or medical treatment was required. Many companies are using a more formal system of reporting incidents and accidents and ignoring the Green Card, which is causing minor incidents to go unreported to WCB. This is where members are running into problems.

That cut or scrape or mild strain in your back that you received at work seemed like nothing, but it became a more serious injury a few days or weeks later. Now you are in a position where it may be argued that as you failed to report an injury or you have no proof of the incident.

#### **HEALTH & SAFETY**



#### The Union Encourages You That If You Sustain An Injury At Work:

1. Fill in a Green Card and make sure the supervisor/ manager who you reported the injury to signs the form as well. If they refuse, write 'refused to sign' and give a copy to a trusted co-worker, committee member or shop steward and ask them to keep it in a safe place. Keep your copy in a safe place too.

At some workplaces you may be instructed to report to the nurses' station – make sure you do. REMEMBER, reporting to the nurses' station does not mean a claim for WCB benefits has been filed.

2. See your personal medical practitioner as soon as possible if necessary. Make sure you tell your doctor that it is a work-related injury. Your practitioner must report all WCB claims. You can also call WCB yourself at 1-800-362-3340 or 204-954-4100.

Remember: You must also follow the company policy on the reporting of work injuries.

## Perseverance pays off

#### Impact Security ordered to pay over \$60,000

n July of 2009, the union filed three policy grievances against Impact Security as it had fallen seriously behind on submitting dental, trust fund and union dues payments. With regards to the union dues, the employer had deducted these amounts from the employees' wages but had never forwarded them to the union.

Immediately prior to the arbitration hearing into these matters, set for May of 2010, the parties agreed that the arbitrator would issue a consent order that dealt with the issues grieved. A consent order is generally a voluntary agreement worked out between two or more parties to a dispute, which is then formalized by the arbitrator. A consent order has the same weight as if the arbitrator had made an actual decision after holding the hearing. If either party does not comply with the order, the arbitrator or court can enforce the order.

In this particular instance, Impact Security agreed in the consent order that it would, on a go-forward basis, follow the collective agreement with regards to the payments due. The order also set up a payment plan for Impact to follow so that it could have some time to pay the arrears that it owed to the union as well as the trust fund and the dental plan. Impact Security followed the payment plan for approximately three months and then stopped paying the amounts in arrears.

As a result of Impact Security not following the agreed to repayment plan contained in the consent order, the union sent the matter back to the arbitrator who had originally issued the order.

In December of 2010, the parties again went before the original arbitrator who had issued the consent order only a few months prior. The arbitrator, after hearing from the parties, issued a new order that stated, amongst other things, that Impact Security was to immediately pay the amounts owed to the union pursuant to the original consent order.

As Impact had paid \$4,500 to the union prior to the new order, the sum of \$56,396.06 was still owed to the union.

In January of 2011, the union filed the arbitrator's new award with the Court of Queen's Bench. The arbitrator's award could then be enforced as an official Court Order.

That being said, the employer still did not come forward with amounts owing so the union took out a lien on a property that Impact Security owned. A lien is the legal claim of one person upon the property of another person to secure the payment of a debt.

In early March 2013, the union was contacted by representatives of Impact indicating that they would like the lien removed from its property. The union agreed that if Impact Security paid the \$56,396.06 owing it would remove the lien.

Shortly thereafter, in May of 2013, Impact sent a cheque for the amounts owing to the union, which paid the arrears to the dental and trust funds.

## Commitment t Brandon Less hogs than anticipated

Plant Manager Morgan Curran-Blaney at the Maple Leaf plant in Brandon sent a memo to employees on August 20 informing Local 832 members how the company would be dealing with the lower volume of hogs the plant has been receiving. Maple Leaf had originally hoped it would be ramping up production in September, and be at higher levels for 2014. Unfortunately, this plan did not pan out and the company has opted to temporarily modify operations throughout 2014. (See changes.)

Usually when a company hits production issues, workers are the first to see hours scaled back, and sometimes layoffs occur. It creates a lot of instability for the workers, many in Brandon are new to Canada and have worked hard to establish roots in the community.

Recognizing the investment it has made over the years to recruit and train dedicated workers, Maple Leaf has chosen to take a path not frequently travelled by companies today.

UFCW Local 832 President Jeff Traeger thought it's the best news that could come at a difficult time.

"Right now we have a shortage of hogs in Canada. I give Maple Leaf credit for ensuring our members will maintain their hours and keep working through this difficult time for the company. Hopefully things will change for the better quicker than anticipated."

- KILL FLOOR With the lower numbers we have made the decision to reduce the line speed on the PM Shift Kill. We will be adjusting our process and moving people to different areas in order to keep the balance between hours and efficiency. Our goal is to continue to keep everyone employed while running at the lower line speed. The Kill AM shift will not be affected and will run at the regular staffing and line speed.
- CUT FLOOR On the Cut PM shift we have recently been running the conversion lines after the cut has finished in order to maximize the amount of value added product we produce. In adjusting to the lower kills, we will be increasing the amount of after-cut conversion we currently do. We are training non-conversion employees so that they have the ability to convert product after the cut as well. The Cut AM shift will not be affected and will run as per usual.

## ta Park Conciliation Progress slow, but some headway made

n August 27, the union and the Vista Park Lodge negotiating committees met with a government-appointed conciliator in an effort to move towards reaching a new collective agreement, with another meeting on August 28. The union and the company had not met since early July.

Conciliation progressed slowly, but the parties did make some headway. At press time, Vista Park still had several major concessions on the table including drastically changing the no contracting out language, deleting past practice language, and having regular hours changed—all the employer would have to do is give six weeks' notice, and an employee's start and finish times could be changed by up to two hours.

In addition, the employer is seeking a two-year wage freeze. Although wage freezes have appeared in some recent public-sector agreements, Vista Park is not in the public-sector. Extendicare (who owns Vista Park Lodge) is a private, for-profit corporation and it has given absolutely no justification for the wage freezes. Wages at Vista Park are already significantly below public sector health care workers, and this would just make the gap wider.

The union is not willing to accept concessions and will continue to try to reach the best deal possible for its members, however, is also prepping for strike action if it should become necessary.

### Be Prepared Security guards must be ready for cold temperatures

s summer is coming to an end, with the fall and winter months just around the corner, you may be required to work outside in cold temperatures. It is imperative that all security officers, supervisors and managers understand the risk of exposure to cold temperatures.

#### The Effects of Cold on Performance

The ability of workers to function and work normally is affected by exposure to cold conditions. The changes to human performance under such conditions are due to two factors:

- 1. the environmental temperature; and
- 2. the clothing required to function at a particular temperature.

As temperature decreases and the duration of exposure increases, the following changes can be experienced:

- 1. reduced dexterity of the hands and feet;
- 2. reduced sensation;
- 3. impaired ability to perceive heat, cold, and pain;
- 4. reduced joint mobility;
- 5. reduced grip strength;
- 6. hypothermia (reduced body temperature, which in its extreme can result in death)
- 7. frostbite (frozen tissue, or frost nip very mild, superficial freezing of exposed skin;
- 8. reduced coordination; and
- 9. reduced decision-making ability.

Your collective agreement has language to protect you in cold temperatures. Make sure you read your collective agreement and should you have any questions contact Martin Trudel, your union representative, at 204-786-5055 or martin.trudel@ufcw832.com.

#### Supervisor Responsibility:

It is the supervisor's responsibility to ensure the safety of their employees by being aware of the current temperatures and the effects they can have on an individual. Supervisors must also ensure their employees understand how to work and dress for work in the cold.

#### Employee Responsibility:

The human body functions most efficiently within a narrow temperature range. At 2°C above or below the body's normal temperature of 37°C, additional stress is placed on the body to regulate its temperature, e.g., shivering to keep warm and perspiring to keep cool. Sources of heat external to the body can help to maintain and regain body temperature. However, preserving the heat generated internally by the body and maintaining the body's ability to produce this heat are keys to maintaining personal comfort and performance in the cold.

Safeway gas bar members across the province of Manitoba ratified a new three-year deal on July 31 in Brandon and August 1 in Winnipeg. Members will see an increase to the relieving rate of 50 cents per hour, up from 40 cents. The increase will also be the same for the Team Co-ordinator position. Service technicians will see a top rate of \$11.75 after 4,000 hours and Team Co-ordinators will go up to \$12.75 after 2,500 hours. All employees averaging over eight hours per week received a lump sum payment. The lump sum payment, ranges from \$150 to \$250, is based on hours accrued and classification.
