

**General Membership Meeting
Wednesday, July 21, 2021 at 7:00 p.m.**

The General Membership meeting was called to order at 7:00 p.m. by Jeff Traeger, President, who chaired the meeting.

2. **2021 Town Hall Meetings:** President Traeger requested that before the meeting is formally started, he would like to again say Thank You to all of the members who continue to work on the front lines during this pandemic.

President Traeger then reviewed the format for the Telephone Town Hall meeting today which will be to take nominations for the recorder position and the 17 vice president positions on the Executive Board. The elections will take place later in the year and the four year term of office will begin on January 1st, 2022.

The minutes of the last meeting, the Secretary Treasurer's report and the President's report are all posted on the Local 832 website for the membership to read and review.

President Traeger introduced Sonia Taylor as the general elections chairperson and full time negotiator Joe Carreiro who is currently training as the chairperson to run the future elections.
